- F) To promote and inculcate the dignity of labour, the appreciation of intellectual gifts and talents of all kinds.
- G) To develop disciplinary conduct and a habit to observe the rule of law and self-restraint.
- H) To bring out, encourage and develop the inventive and research faculties of the pupils and teachers and to afford opportunity for research works and invention.
- I) To encourage sportive and adventurous spirit in the pupils and those connected with the Institution.
- J) To arrange any activity or activities which may be helpful or conducive for the realization or achievement of the objects.
- K) To hold and conduct Fairs, shows, Exhibitions, Souvenir, Raffles etc., germane to the cause of education.

2. To invest, dispose of transfer and otherwise deal with the moneys, funds and properties in such manner as to enable the association to carry out the object effectively.
3. To accept donations, grants, presents and other offerings in each or in kind and to deal with the same for the purpose of the association.
4. To charge moderate levies to recover themselves for the outlay and expenses incurred in the uplift and maintenance of the institutions established or about to be established.

IN THESE BYE LAWS :-

1. The **COMMITTEE** shall be called "**The Srivilliputtur Lions School Committee**" and it has been established by the efforts and initiative taken by the members of Lions Club of Srivilliputtur.
2. "**EXECUTIVE COMMITTEE**" means the Executive Committee consisting of the members elected from the Lions School Committee.
3. "**THE PRESIDENT**" means The President of the Srivilliputtur Lions School Committee.
4. "**THE SECRETARY CUM CORRESPONDENT**" means the secretary cum correspondent of Srivilliputtur lions school committee.
5. "**THE TREASURER**" means the treasurer of Srivilliputtur lions school committee.
6. "**THE LIONS CLUB**" means The Lions Club of Srivilliputtur. The Registered Office of the Committee shall be located at N.G.G.O Colony, Srivilliputtur where ordinarily all meetings shall be held.

11. Membership & Subscriptions

a) A member of Srivilliputtur Lions Club having membership more than 5 years is eligible to become the member of the Srivilliputtur Lions School Committee. He shall be eligible to become the member of the Executive Committee only after the completion of 7 years from the date of his joining Srivilliputtur Lions Club. He is eligible to hold the post of President, Secretary cum Correspondent and Treasurer only after the completion of 10 years from the date of his joining the Srivilliputtur Lions Club. A member of the Srivilliputtur Lions Club can apply to Srivilliputtur Lions School Committee to become a member in that committee after the completion of 5 years from the date of his joining in the Lions Club of Srivilliputtur. The Committee shall consider and approve his application or reject. The Committee's decision is Final. There is no appeal.

b) A member of the Lions School Committee shall pay annual subscription of Rs.250/- every year in the month of 31st day of August and shall obtain receipt. On default of payment of the subscription within the period, such member shall be removed from the Committee by resolution.

- c. The Principal of the Institution run by the Committee shall be an Ex-Officio member of both the School committee and Executive Committee, but shall have no right to vote.
- d. The President, Secretary and Treasurer of the Lions Club of Srivilliputtur of the concerned Lionistic year will be Ex officio members of the Executive and General Body Committee. They can offer suggestions but not empowered to sign in the resolutions of the Executive Committee and the General Body Meeting.

13. YEAR OF COMMITTEE

The year of committee starts from 1st April to 31st March of the succeeding year as per English Calendar.

14. EXECUTIVE COMMITTEE

- a. The Executive Committee shall consist a maximum of 9 members inclusive of President, Secretary, cum Correspondent and Treasurer Nine Members will be elected from General body for the Executive Committee.
- A1. The Lions Primary School run by The Srivilliputtur Lions School Committee shall be governed by an Executive Committee of 7 members consisting of The President, Secretary & other five members elected by the General body of The Srivilliputtur Lions School Committee.
- A2. The Srivilliputtur Lions School Committee Srivilliputtur proposed to establish another school in the name of Savi Lions International School (CBSE) and it shall be administered by an Executive committee consisting of 9 members including the President, Secretary cum correspondent and Treasurer and they are unanimously selected in this meeting.
- b. The period of Executive Committee is 3 years from the date of election. The Executive Committee elected will select the President, Secretary cum Correspondent and Treasurer among them.
- c. The Executive committee shall meet as and when required and at least minimum of 6 meetings per year shall be Conducted. Quorum of Executive committee shall be Five members.
- d. The resolution passed by the Executive Committee shall be approved by the Committee in its next succeeding meeting.
- e. A) The elected President, Secretary, Correspondent and Treasurer will be holding the post for 3 years. They are eligible to continue in the Executive Committee in the coming years and they can hold the other posts which they did not hold during the preceding period of three years. This continuation is for the second term only. In total they shall not hold any of the three posts the posts after 6 years. They are eligible to hold the above mentioned posts only after the completion of 3 years succeeding the 6 years

- f. The Executive Committee has got all powers relating to the appointments, disciplinary action regarding the employees of the committee, administration of the Institution of the Committee.
- g. The appointment of the school staff shall be done by the appointment Committee which shall consist of the Secretary cum Correspondent and two other members of the Executive Committee.
- h. Any member Whose actions are against the objectives of the committee (or) bring disrespect (or) dishonor to the committee shall be removed from the membership.
- L Rules of Removal**

Such members will be given a notice and reply to the notice received within 7 days. The reply will be placed before the executive committee. The Executive Committee shall hold the enquiry, and find the facts. The Executive Committee shall place its findings before the General Body and find the facts. The Executive Committee shall place its findings before the General Body Extra-ordinary General Body shall be convened. The decision of the General Body is final.
- j. Those who didn't attend three consecutive meeting will be deemed to forgo his membership. In case if he intimate his inefficiency to attend the meeting in advance to the Secretary in writing they are exempted from this disqualification.

15. GENERAL BODY

- a. Submission of Annual Accounts.
- b. Before the end of September of each Calendar Annual year the general body meeting shall be convened. Quorum for General Body Meeting shall be 3/5 members.
- c. A clear 21 days notice in writing shall be given to convene the Annual general body meeting.
- d. Extra ordinary general body meeting at the request of 3/5 members in writing to the president shall be convened. If the President fails to comply with such request, they themselves can convene the meeting giving clear 7 days notice in writing. If any urgency arises the President himself may convene the extraordinary general body meeting giving clear 7 days notice in writing.
- e. All the Acts done by and resolution passed by the Executive Committee shall be approved and ratified by the general body.

- f. The general body has got all the powers to alter or amend any of these Bye Laws as and when required by giving 21 days clear notice, to its members. 2/3 majority of members present shall be required for changing byelaws or adding to them.

16. FUNCTIONS :

A. PRESIDENT

- a. The president shall be elected by the committee and he shall hold office for three year from the date of his election.
- b. The President shall convene the meeting of Committee and E.C in consultation with Secretary cum Correspondent and he shall preside over all the meeting of the Committee and Executive Committee.

B. SECRETARY CUM CORRESPONDENT.

- a) Secretary cum Correspondent shall be elected by the Committee and he will hold the office for three years from the date of his election.
- b) The Secretary cum Correspondent will look after the day to day affairs of the Committee and the Institutions subject to the supervision and direction of the Executive Committee.
- c) The Secretary cum Correspondent will be responsible for maintaining of funds, operation of bank accounts and for all receipts and disbursement accounts of the committee along with the Treasurer.

C. TREASURER

- a) The Treasurer shall be elected by the committee and he shall hold office for three year from the date of his election
- b) The Treasurer will be responsible for maintaining of funds, operation of bank accounts and for all receipts and disbursement accounts of the committee along with the Secretary cum Correspondent. Funds shall be operated in any banks within the Municipal Limits of Srivilliputtur town as decided by the Executive Committee then and there, to be operated jointly by the Treasurer and Secretary cum Correspondent.

17. BANKS

Funds shall be operated in any Banks within the Municipal limits of Srivilliputtur town as decided

by the executive committee then & there to be operated jointly by the Treasurer & Secretary Cum Correspondent.

19. INSPECTION

The minutes Book and account Books shall be opened for inspection by any member of the Committee either during the meeting or after giving 3 day notice to the Secretary cum Correspondent at the premises of the school.

20. ADMINISTRATION CONTROL AND APPEAL

The executive committee shall have power to take all the necessary disciplinary action over the staff of the institution. The correspondent or any other member of the executive committee is authorised to issue the orders of dismissal or any other disciplinary action over the staff of the institution.

21. AUDIT

The account of the committee shall be audited by a qualified auditor (amended w.e.f. 2nd Jan'81) appointed by the General Body.

22. PROPERTIES:

The properties whether movable or immovable shall be purchased or sold in the name of the school committee by the **Secretary cum Correspondent** after getting due authorization from the Lions school Executive Committee, and the Secretary cum Correspondent shall maintain the Register of properties.

The funds and properties of the Association cannot in any event be divided among the members of the Committee. The funds and the properties and income of the committee shall be applied only for the promotion of the objects of the Committee.

22 A. : OBTAINING LOAN / ADVANCES :

Loan/ Advance can be available for purchase of land , construction of building, improvement over the existing assets of any other movable or immovable properties for the school for the betterment of

Education from any Bank / Financial Institution . The Secretary / Correspondent is the authorized person to execute the necessary loan / advance documents on behalf of the School.

For availing the loan / advance as mentioned above necessary resolution should be passed at the General Body meeting of the school Committee and the Secretary / Correspondent should be authorized by the General Body to Execute the loan / advance documents on behalf of the school.

23. LEGAL PROCEEDINGS:

Legal proceedings by or against the committee shall be conducted in the name of the secretary cum correspondent. Before taking any action or defending any action against the committee, the matter shall be discussed by the Executive Committee and the proceedings shall be taken as per the decision of the executive committee.

24. RETURNS TO DISTRICT REGISTER:

All statements and returns duly filled with, shall be sent to the District Registrar by the **President** and **Correspondent** by paying the required fees.

25. BYE LAW COPIES:

Copies of Byelaws, the Receipt and Expenditure Account and Balance sheet shall be given to members on payment of Rs 5/- to each of the records.

26. SAVINGS:

For any rules which are not noted here, the rules in the Tamil Nadu Registrations Rules 1978 shall apply.
